The approval process may take up to thirty (30) days. Please note Tenant Evaluation fee has always been non-refundable. This policy is communicated multiple times during the application process to ensure clarity before any payment is made. TE no-refund policy for all applications is due to the nature of the services provided. Tenant Evaluation will no longer approve any refund requests after the application has been processed

INDIVIDUAL COMMUNITY REQUIREMENT CHECK LIST

APPLICATION FEES: Non-refundable online processing fee: \$150.00 per applicant or married couple. (<i>Payable through Tenant Evaluations</i>) **
Clear photo-copy of valid State ID, Driver's License, or Social Security Card or Passport must be provided.
Copy of Current Vehicle Registration and Proof of Insurance must be provided.
Copy of Fully Executed Purchase / Rental Agreement / Occupancy Authorization letter by the homeowner. A letter of occupancy authorizing occupant is required from owner of unit for person(s) being added to an existing lease if no lease is generated for residency.

COMMUNITY INFORMATION:

- 1. Application fee \$150.00 per person (18 & older) OR per Married Couple (Separate Last Name Marriage Certificate is required).
- 2. Minors living with parents do NOT need to submit an application.
- 3. Copy of SIGNED Lease or Purchase Agreement. A letter of occupancy authorizing occupant is required from owner of unit for person(s) being added to an existing lease if no lease is generated for residency.
- 4. Minimum lease term is 30 days. 3 times per year.
- 5. Submit TWO forms of ID. Choose TWO of the following: Driver's License, Social Security Card, or Passport.
- 6. A LEGIBLE copy of Vehicle Registration(s) and Insurance must be attached.
- 7. The Estoppel/ Resale Package have to be completed before the approval for Purchase
- 8. If a unit has a balance on the account, the Association have to be paid in full before the Sale / Rental can be approved. The account must be brought current before any application can be considered for approval by the Association.
- 9. Owners are allowed to register 3 vehicles.
- 10. Lease holders and non-owner resident units may only register 2 vehicles.
- 11. Vehicles must be less than 20' and/or less than 8'tall (including any item on the roof)
- 12. Lease holders and non-owner resident units may not have pets.
- 13. Owners are allowed to have 1 pet, no more than 10 pounds.
- 14. Processing of application may take up to 30 days. Once screening has taken place, the application is sent to BOD for review, the processing will begin only after application is completed and signed.
- 15. Unit must be inspected by Property Manager (Account must be current) prior to approval by BOD.
- 16. Final Interviews are conducted on Wednesdays 1pm to 5pm
